I expressly and voluntarily assume all risk and liability for the loss or damage to any 4RUNNER/ DIRT BIKE obtained from NOMADAS DRIFT, for the death or injury to any person or property, and for all other risks and liabilities arising from the use condition and possession of the above identified.
4. COVENANT NOT TO SUE. I agree and covenant on behalf of myself, my children and any minor for whom I am the guardian, I will never directly or indirectly institute any legal, equitable, administrative, or other action complain proceeding against NOMADAS DRIFT.
5. I/we certify that we have read the Rental Agreement and Waiver of Liability and understand and agree on the conditions. This document will execute it in good faith and with full knowledge of its significance.
